

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.dysoncreativephotography.com and Dyson Creative Photography and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Dyson Creative Photography include www.dysoncreativephotography.com, Click With Photography, Dyson Creative Photography, www.dysoncreativephotography.com and www.clickwithphotography.com. The Click With Photography website is a professional photography & photography education site. By using the Click With Photography website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Click With Photography may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Click With Photography's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
